**ORDER OF THE SUPERIOR COURT CONCERNING FINAL APPROVAL OF
ATTORNEYS' FEES, EXPENSES AND SERVICE AWARDS**

After consultation with Judge Saris of the United States District Court for the District of Massachusetts¹, the Court:

1. Awards attorneys' fees in the amount of 25% of the common fund of \$15,350,000.00. Said amount takes into consideration the lodestar figure as well as the benefits the participants achieved through this settlement²;
2. Approves the request for a service award in the amount of \$2,500.00 for each representative plaintiff to be paid from the common fund.

¹ See *In Re Shields Health Group, Inc. Data Breach Litigation*, 22-10901-PBS. The Superior Court and the U.S. District Court conducted a settlement approval hearing in a joint sitting at the Norfolk Superior Court on December 16, 2025.

² The requested fees were 33 1/3 % of the common fund; \$5,116,666.67. The lodestar yields \$3,018,672.54. 25% yields \$3,837,500.00.

3. Approves expenses in the amount \$76,276.04 to be paid from the common fund.
4. Orders the parties to prepare a proposed order consistent with this Order by February 27, 2026.
